

Notice in accordance with Art. 13 and 14 of EU regulation 2016/679 and D.lgs. 196/03, as amended
Applicable legislation on the protection of personal data

1. Type of personal data

The Undersigned society, as Data Controller of the treatment, hereby informs you that the data, qualified by the current legislation as personal, provided by you, even verbally or collected through the related form, or at third parties (as for example exhibitions, magazines or newspapers, records, lists or public data base, association, other public entities, etc) normally referred to as Company name, seats address, telephone and fax number, e-mail address, name and surname, mobile number, any internal contact name, might be treated in respect to the applicable legislation in the protection of personal data and fairness, legality, transparency and privacy obligation.

2. Purpose of the treatment, legal basis and transmission of personal data

The processing of data will be made for the following purposes

- sending of communication of our initiatives for example participation to exhibition, event organisation, anniversaries, kick-off of new products, sending of newsletter, promotional and commercial communication, direct sale activity and marketing research, including surveys on the quality and satisfaction of our services and/or products, through remote communication techniques including automated contact (as SMS, MMS, fax, automated telephone call, e-mail, multimedia messages on web platform) and traditional (as ordinary post and telephone call made by the operator).

For the a.m. purposes, the data provision is optional and consequently, in case of refusal by your side, there will not be any consequences, except the impossibility to put in place initiatives aimed at improving our services or products towards you, as well as to keep up-dated your information on the development of our promotions.

3. Method and duration of data processing

The processing of your data will be made through documents and paper archives and electronic and/or telematic instruments in compliance with law regulation with the aim to grant privacy and security, integrity and disponibility, as well as the accuracy, the up-date and the relevance of the data with respect to the a.m.purposes and to avoid the access and related processing by non authorised entities.

Your personal data will be preserved by the undersigned for all the time of the legal relationship and with reference to the purposes indicated in paragraph 2 until you will inform us that you are not interested anymore to our commercial and/or promotional communication and or advertising.

4. Data diffusion, transfer and communication

Notwithstanding the communication made by the execution of obligation foreseen by law, regulation and community legislation, your data will be processed by the employees and cooperators of the undersigned with reference to their job and might be communicated in Italy: i) other Societies of the group controlling, controlled and/or connected; ii) to categories of entities that needs to access to your data to reach the goal for which the data are collected. These categories of entities process the data for the a.m. purposes as independent controller.

5. Rights of the person concerned

With reference to the data, and in every moment, you might exercise the rights foreseen by artt. from 15 to 22 of the regulation (UE) 2016/679, through a simple written request to the data controller even by e-mail or ordinary mail, Pec or delegated entities, according to the procedures laid down in art. 12 of EU regulation (UE) 2016/679 and to the limitation foreseen by Title I – Cape III of D.lgs. 196/2003 as amended, in order to: (i) obtain the access to personal data to know data origin, purposes of the treatment, logic applied to the treatment with the use of electronic instruments, categories of data, addressee's (or addressee categories) to which the same will be communicated, period of conservation and their communication in an intelligible form; (ii) obtain the modification, the integration, the cancellation of data or the limitation of the treatment (iii) oppose to the treatment of personal data; (iv) obtain the portability of data where appropriate; (v) withdraw the consent in any moment; (vi) suggest a complaint according to art. 77 of UE Regulation 2016/679, in case you believe that the treatment breaches the applicable law with regards to protection of personal data. The data controller for the protection of personal data or the data controller of the EU country where normally live and work or the place where the alleged infringement is occurred.

Furthermore, the list of the entities to which the data are communicated or that become aware of it as Responsible and/or authorised entities is at your complete disposal at the Data Controller.

Finally, the Data Controller informs you that the data communication, following up your request or exercise of your rights, might take place prior to an expenses reimbursement.
